 - b. “to . . . serve as an informational liaison between the sheriff's department, the police department and the citizenry at large on law enforcement activities, programs and initiatives.”
- 2) **State statute** includes . . . (KS Statute 22-4610)
 - a. “advise and assist in policy development, education and community outreach and communication related to racial or other biased based policing by law enforcement officers and agencies.”
 - b. “Receive training on fair and impartial policing and comprehensive plans for law enforcement agencies.”
