ORDINANCE NO. O-_____-21
RESOLUTION NO. R-_____-21

**AN ORDINANCE AND RESOLUTION OF THE UNIFIED GOVERNMENT OF
WYANDOTTE COUNTY/ KANSAS CITY, KANSAS TO APPROVE EXCEEDING THE
REVENUE NEUTRAL RATE.**

WHEREAS, the Unified Government of Wyandotte County/ Kansas City, Kansas is the consolidated government for Wyandotte County, Kansas and Kansas City, Kansas; and

WHEREAS, on or before June 15, 2021, the Unified Government Clerk calculated the revenue neutral rate for each taxing subdivision and included such revenue rate on the notice of the estimated assessed valuation provided to each taxing subdivision for budget purposes; and

WHEREAS, the Unified Government notified the Unified Government Clerk by July 20, 2021, of its proposed intent to exceed the revenue-neutral rate and provided the date, time and location of the public hearing and its proposed tax rate through the adoption of Resolution No. R-44-21 on July 15, 2021; and

WHEREAS, at least 10 days in advance of the public hearing, the Unified Government published notice of its proposed intent to exceed the revenue neutral rate by publishing notice on the website of the governing body and in a weekly newspaper of the county having a general circulation therein; and

WHEREAS, the budget proposed by the Governing Body of the Unified Government of Wyandotte County/ Kansas City, Kansas will require the levy of a property tax rate exceeding the Revenue Neutral Rate.

**NOW, THEREFORE, BE IT ORDAINED AND RESOLVED BY THE
GOVERNING BODY OF THE UNIFIED GOVERNMENT OF WYANDOTTE
COUNTY/ KANSAS CITY, KANSAS:**

Section 1. The Governing Body of the Unified Government of Wyandotte County/ Kansas City, Kansas hereby approves exceeding the revenue neutral rate, which is required prior to adoption of a proposed budget that will result in a tax rate in excess of the revenue neutral rate, but not to exceed the proposed tax rate as stated in Resolution No. R-44-21 of a proposed mill levy for the City of Kansas City, Kansas of 38.4703 mills.

Section 2. The Governing Body of the Unified Government of Wyandotte County/ Kansas City, Kansas hereby approves exceeding the revenue neutral rate, which is required prior to adoption of a proposed budget that will result in a tax rate in excess of the revenue neutral rate, but not to exceed the proposed tax rate as stated in Resolution No. R-44-21 of a proposed mill levy for Wyandotte County, Kansas of 39.3273 mills.

Section 3. The Mayor, the County Administrator, and the Unified Government's other officers, agents, and employees are hereby authorized and directed to take such further action, and execute such other documents, certificates, and instruments as may be necessary or desirable to carry out and comply with the intent of this Ordinance and Resolution.

This ordinance and resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.
