**A RESOLUTION OF SUPPORT FOR UTILIZING THE FORMER REARDON
CONVENTION CENTER FACILITY AS A TEMPORARY COLD WEATHER
SHELTER FOR THE UNHOUSED.**

WHEREAS, the Unified Government Board of Commission of Wyandotte County/Kansas City, Kansas supports finding short and long-term solutions, collaboratively with all interested stakeholders to address the needs of the unhoused population in our community; and

WHEREAS, the Unified Government has entered into a contract with Crosslines Community Outreach, Inc. to provide services, including a temporary cold weather shelter in the former Reardon Convention Center facility through the end of April 30, 2022.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE
UNIFIED GOVERNMENT OF WYANDOTTE COUNTY/KANSAS CITY, KANSAS:

1. That the Unified Government Board of Commission of Wyandotte County/Kansas City, Kansas support utilizing the former Reardon Convention Center facility as the temporary Cold Weather Shelter through April 30, 2022.

2. The Mayor, the County Administrator, and the Unified Government's other officers, agents, and employees are hereby authorized and directed to take such further action, and execute such other documents, certificates, and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution.
