Wyandotte:
Linda Ramirez provided the Director's report.

- Linda announced that all III-B and Senior Care Act In home support programs are currently on a wait list for both Wyandotte and Leavenworth counties. Funding is available for Caregivers under the Title III-E funding.
- Linda shared that November is National Caregivers' Month. In celebration, the Wyandotte County office is providing meals to the caregiver and care recipients daily for an entire week.

- Linda announced that Linda Brown, advisory member appointed by Commissioner Bynum has resigned. Ms. Brown is moving out of Wyandotte County and will no longer be able to serve.
- Linda reported that Mrs. Modestine Bell, an 18-year In-House volunteer passed away Sunday, November 6, 2022. Mrs. Bell was currently serving as a Silver Haired Legislator as a Wyandotte delegate.
- Linda also reported that Lynn Randle, Information & Assistance Specialist passed away suddenly on Wednesday, November 9, 2022. Lynn began her tenure with the Unified Government in 1998 as a driver for senior transportation. She transferred to the Aging Department in 2018 and became an Information Specialist.
- Linda reminded the group that the Christmas in November event will be held November 17, 2022 (tomorrow) 2-4pm at the Area Agency on Aging. Four 12-passenger vans will be given to each stand alone congregate meal site for daily transportation.

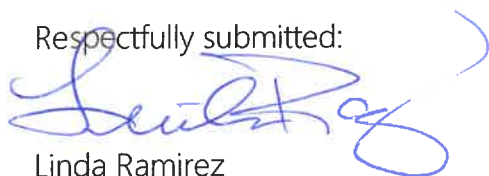
NEXT MEETING:
