CALL TO ORDER: Jamey Rodriguez called the meeting to order at 10:05am.

MINUTES: No February minutes were sent as the February meeting was cancelled.

**CHAIRMAN
COMMENTS:** No opening remarks were made.

COUNCIL CONCERNS: Leavenworth County:

➤ None.

Wyandotte County:

➤ Jamey Rodriguez asked the council to approve a letter be written on their behalf to those Wyandotte County commissioners who have vacant positions on the council encouraging them to appoint someone to those positions. The council voted to allow her to compile the letter. Jamey will send the letter to Linda Ramirez for distribution and the council members will vote at the April meeting for approval as written.

DIRECTOR'S REPORT:

Leavenworth:

➤ Connie Harmon announced that the Leavenworth Council on Aging (LCOA) is now in their new building and fully open to the public. The LCOA are seeing record numbers of attendance at their activities and events.

- Connie shared that their Nutrition team is delivering meals with their local city officials in honor of *March for Meals*.
- The Public Hearing for Leavenworth County will be held on Wednesday, April 19, 2023 from 1:30 – 3:30pm at the new LCOA location (711 Marshall Street in Leavenworth, KS).
- Connie announced that the LCOA will host their Volunteer Appreciation Luncheon on April 21, 2023. They will host their luncheon at their location and have over 100 volunteers to that will be recognized.
- Based on community feedback, the LCOA launched a new trip series called B.L.A.S.T. It stands for *Bucket List Adventure Series Trips*. This group will be going zip lining in May.

Wyandotte:

Linda Ramirez provided the Director's report.

- Linda reported that the wait list for both Senior Care Act (SCA) and Older Americans Act (OAA) Programs remain. No waiting for service under the Title III-E Caregiver Program.
- Linda reminded the council that an in-service for Advisory Council Members is still being planned, no date has been set. The in-service program will be held to teach council members how to be better advocates for seniors.
- The Older Americans Month Celebration (Sock Hop) is scheduled for May 25, 2023 at the George Meyn Community Center, 11am-2pm.
- Linda mentioned that the Older Kansans Day trip to Topeka was a success and that two of the "talking points" have moved forward with hearings at the Capitol.
- Linda shared that a *Senior Resource Day* sponsored by the Unified Government is scheduled for Friday, March 31st. This is the last day to apply for the Senior Citizens Utility Tax Rebates. The Area Agency on Aging will be at the event and provide information by hosting a table.

- The Area Agency on Aging will host their *March for Meals* event on Thursday, March 23, 2023. The event will be held at Strangers Rest Baptist Church, 11am – 12pm. Mayor Tyrone Garner and the Regional Director of the US Department of Health & Human Services are expected to be in attendance.
- The Public Hearing for Wyandotte County will be held on April 4th at the West Wyandotte Library, 10am – 12pm. These meetings are required by the State through our Area Plan that is submitted annually.

OTHER BUSINESS:

- Jamey Rodriguez shared an upcoming PACE event scheduled for April 15, 2023. The event will be held at the PACE Center and will show the importance of getting Legal documents in place.
- Linda Ramirez did announce and welcome three new members to the council who were in attendance, Carlen Davis, Denise Bias and Cindy Hopewell. Linda also mentioned that Camalla Leonhard had resigned.

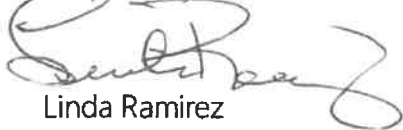
