CALL TO ORDER: Jamey Rodriguez called the meeting to order at 10:03am and had no opening remarks.

MINUTES: The July minutes were approved as written.

**CHAIRMAN

DIRECTOR'S REPORT:

Leavenworth:

➤ Connie Harmon announced that excavation began last week on their new parking lot. The new lot will be gated and lit to hold their 31 fleet vehicles and was funded by a KDOT grant.

➤ The Leavenworth Council on Aging (LCOA) Leisure & Learning Program staff will take 25 seniors on a kayaking trip to Perry Lake on August 28th. A trip to the New Theatre & Restaurant to see Dreamgirls is also scheduled for September 6th.

- All LCOA Medicare counselors have received their refresher training in August and are ready for Open Enrollment in October.
- The Human Services team is working with University of St. Mary physical therapy department and St. Luke's Hospital on a falls prevention event scheduled for September 22nd.
- The Leavenworth Council on Aging plans to relocate two of their congregate dining sites. Beginning October 2nd, the congregate site in Basehor will shift from Hickory Villas to Basehor United Methodist Church. In December, the Tonganoxie site will shift from the Florence Riford Senior Center to West Haven Baptist Church. Both new locations are larger spaces with large, accessible parking areas.
- A flu clinic will be held at the Council on Aging in conjunction with Walgreens on October 4th. Participants will be eligible to sign up for flu, pneumonia, RSV, and Shingles shots.

Wyandotte:

Linda Ramirez provided the Director's report.

- Linda announced that a successful Town Hall/Public Hearing was held on August 1st at Victory Hills Baptist Church. Several Representatives were on the agenda to speak along local Commissioners who attended. The event finished up with a Q/A session and lunch.
- Linda shared that the volume of assessments has went up as Medicaid income caps were raised. The Wyandotte office is currently in the process of hiring more contractors to assist with the influx of assessments. We've also noticed an increase in MOWs applications.
- Linda has been working on the *Steppin' Back Into the Classroom* project for grandparents. The budget has been set, the deadline to apply is September 15th. The plan is to purchase tennis shoes and hoodies.
- Linda announced that funds for Transportation and Legal Services have been exhausted. New funding for transportation will resume in October.

- The Area Agency on Aging will be opening a new meal site at the Armourdale Community Center this fall. The AAA will share its grand opening date when it has been set.
- The AAA is currently interviewing for a new Fiscal Officer. This comes as our Fiscal Officer was removed and placed at the Unified Government Transit Office in March 2023. Now, 6 months later, we have been given the green light to move forward with a replacement. Former Fiscal Officer, Deasiray Bush has been named Transportation Director for the Unified Government.
